You are about to purchase a product that is not simple and may be difficult to understand.

## 1. What is this product?

Type $\quad$ This product is an unsecured debt instrument governed by Irish law.
It is a bond for which the Client pays an amount and the Issuer assumes, on the Maturity Date, the obligation to pay part or all of the nominal amount of the bond ("Product Nominal Amount"), depending on the performance of one or more Underlying, without the commitment to return the Product Nominal Amount in full. In addition, the Issuer grants its holders the right to receive a Remuneration (as defined below), provided that conditions linked to the evolution of one or more Underlying are met.

Objectives The payment of the Coupon and the refund of the Product Nominal Amount will depend on the fulfilment of certain conditions, linked to the performance of the Underlying.

## Underlying

The product performance is linked to the ordinary shares of NVIDIA CORP in USD (ISIN: US67066G1040 and Bloomberg: NVDA US)
How is performance ("Remuneration") determined?
If on an Observation Date or on the Final Valuation Date the Underlying Value is greater than or equal to the Coupon Trigger, the Issuer pays a Remuneration for each bond equal to the Nominal Amount x Coupon. In any other case, the Issuer does not pay Remuneration.
You will receive on the maturity date:
a) If the Underlying Value on the Observation Date or on the Final Valuation Date is greater than or equal to the Trigger, the Product expires on that date and you will receive the product notional amount; or
b) If the Underlying Value on the Final Valuation Date is below the Trigger but the Barrier Activation Condition has not been verified, you will receive the product notional amount; or
c) If the Underlying Value on the Final Valuation Date is below the Trigger and the Barrier Activation Condition has been verified, the Issuer returns for each bond part of the Product Nominal Amount through the physical delivery of the shares, applying the following formula:

## 2. What are the risks and what could I get in return?

$\triangle$The risk indicator assumes you keep the product until 5 August 2024. The actual risk can vary significantly if you cash in at an early stage and you may get back less. The summary risk indicator is a guide to the level of risk of this product compared to other products. Two elements are taken into account: 1) market risk (risk of volatility of the underlying and interest rate risk): that the potential losses derived from future market performance are classified as high; and 2 ) the credit risk and the probability that a bad market situation influences the Issuer's ability to pay it as unlikely. This table shows the money you could get back over the next three years under different scenarios, assuming that you invest 10,000 USD. The scenarios shown illustrate how your investment could perform. You can compare them with the scenarios of other products. The scenarios presented are an estimate of future performance based on evidence from the past on how the value of this investment varies, and are not an exact indicator. ## 3. What happens if the Issuer is unable to pay out?

If the Issuer goes into suspension of payments or declares bankruptcy, you would have the right to request payment from the Guarantor by virtue of an unconditional and irrevocable guarantee of any amount due. If the Guarantor also goes into suspension of payments or declares bankruptcy, you could suffer a loss of up to the total amount of your investment.
Therefore, Andorra Banc Agrícol Reig, S.A. guarantees the payment obligations that the Issuer assumes in the Product, in the same terms. The product is a debt instrument and as such is not covered by any deposit protection scheme. Therefore, in the event that Andorra Banc Agrícol Reig, S.A. could not pay for being insolvent, the Clients would concur with the rest of ordinary creditors, being subordinate with respect to the holders of issues with privilege or guarantee, and having priority only with respect to holders of subordinated debt, preferred shares and shareholders.

## 4. What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs.
The amounts shown here are the cumulative costs of the product itself, for three different holding periods. They include potential early exit penalties. The figures assume you invest 10,000 USD. The figures are estimates and may change in the future.

## Costs over time

The costs shown in the table below represent how much the expected costs of the product would affect your return, assuming the product performs in line with the moderate performance scenario. Regardless of the impact on its performance in such a case, the estimated entry and exit costs as a percentage of the nominal amount of the product are estimated at $4.50 \%$ if you exchange them after one year, $4.50 \%$ if you exchange them after 2 years and $4.00 \%$ if it is exchanged after the recommended holding period.

## 5. How long should I hold it and can I take money out early?

## Recommended holding period: 3 years

The recommended holding period corresponds to the maturity date of the product. The Product does not allow early cancellation or refund. The Client could sell the Product before its Maturity Date, provided there is liquidity in the market. In this case, the Client will not be entitled to Remuneration and may suffer a loss if the sale price is less than the Invested Amount.
Under normal market circumstances, you can sell this product on the secondary market, at a price that will depend on the prevailing market parameters at the time, which could pose a risk to the amount invested. If you decide to resell the product, a commission of $0.50 \%$ of its market price would be deducted, which may be increased under certain market conditions
