What is this product?

- This product is a class of shares of the Sub-Fund and denominated in EUR. The Fund is an investment company with a variable capital and qualifies as a Special Investment Fund ("SIF"), subject to the Luxembourg law of 13 February 2007 related to SIF and as an Alternative Investment Fund ("AIF") subject to the Luxembourg Law of 12 July 2013 related to Alternative Investment Fund Managers ("AIFM") and transposing Directive 2011/61/EC.
- As an investment fund, the return of the Sub-Fund depends on the performance of its underlying assets.

Investment objective:

■ The Sub-Fund aims at capital appreciation via an active management of a diversified portfolio of international listed equity and equity-linked instruments (including but not limited to ordinary or preferred shares, convertible bonds, UCIs/UCITS). The Sub-Fund may invest in industry sectors such as, but not limited to, utilities, industrials, energy, materials and renewable energies. The objective is to provide investors with geographic diversification, relatively stable returns and income, participation in the global economic recovery and growth, relatively low correlation to other more classic asset classes, a degree of inflation protection, and high barriers of entry due to capital intensity of the business in the target sectors.

Investment policy:

- In the best interest of the Shareholders, and notably for defensive purposes, the Sub-Fund may also retain amounts, up to 100% of its net assets, in cash deposits, cash equivalents, treasury bills, moneymarket securities and ETFs as considered appropriate.
- Each analyst of the Portfolio Manager will generally be responsible for researching between 15 and 20 companies at any given time. Ongoing research involves rigorous modelling of each company, line- by-line tracking of consensus assumptions and active regulatory and legislative research.
- The Sub-Fund's investment thesis originates from industry research, company meetings, periodic company and event calendar review. The thesis is subsequently quantified by the analysts and firmed up by the Sub-Fund 's senior investment professionals who will be engaged in meeting company executives and relevant local regulators. An investment idea is then typically generated when an internal view suggests a different outcome from market expectations.
- Depending on financial market conditions, a particular focus can be placed on a single country.
- The Sub-Fund may use financial derivative instruments for both hedging and/or investment purposes.
- The Sub-Fund may hold up to 20% of its net assets, in ancillary liquid assets which consist of bank deposits at sight in accordance with the provisions of Article 41(2) of the Law of 17 December 2010.

Notwithstanding the above provisions; the above mentioned 20% limit shall only be temporarily breached for a period of time strictly necessary when, because of exceptionally unfavorable market conditions, circumstances such as the September 11 attacks or the bankruptcy of Lehman Brothers in 2008.

- The Sub-Fund is actively managed without reference to a benchmark.
- This financial product does not promote environmental or social characteristics and does not have as its objective a sustainable objective.
- The investments underlying this financial product do not take into account the EU criteria for environmentally sustainable economic activities.
- Given the above investment objective and policy and the risk and reward profile of the product, the recommended holding period is 5 years.

Redemption and dealing: Investors may request redemption of shares monthly, last business day of each month in Luxembourg, no later than 12 p.m., Luxembourg time.

Distribution policy: Non-distributing shares: any income generated by the Sub-Fund is reinvested.

Intended retail investor

The sale of the shares is reserved to well-informed investors only as defined by article 2 of the 2007 Law. This Sub-Fund may be suitable for investors looking for a higher risk income strategy to complement an existing core portfolio, or looking to potentially enhance long-term returns and who are comfortable with the extra risks inherent in the Sub-Fund.

There is no minimum investment.

Term

This product was incorporated for an undefined period. It may be terminated by the board of directors unilaterally under the conditions set forth in the offering document of the Fund or by a decision of the general meeting of shareholders.



What are the risks and what could I get in return?

Risks



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 6 out of 7, which is the second-highest risk class.

Performance scenarios

Markets could develop very differently in the future.

How long should I hold it and can I take money out early?

Recommended Holding Period ("RHP"): 5 years

The RHP has been defined by taking into account the above investment policy and risk and reward profile. You should be prepared to stay invested for at least 5 years. However, you can redeem your investment without penalty prior to the end of the RHP, or hold the investment longer. Investors may request redemption of shares no later than 12.00 p.m.(noon), Luxembourg time, on the business day preceding the next following valuation day. Redemption requests received after this time and date will take effect on the next following valuation day. Any cashing-in before the end of the RHP may have a negative consequence on your investment.
