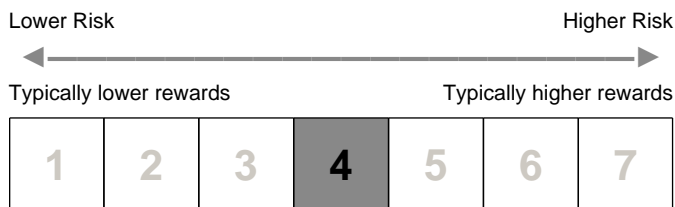

#### Objectives and Investment Policy

- The investment objective of the sub-fund is to achieve capital growth over the long term. The sub-fund looks to provide a strong diversification, selecting different managers, intended to help the investors to achieve the security and the return they are looking out for their savings.
- The sub-fund will invest in units of other UCITS and/or other UCIs such as total return funds, equity funds, mixed funds, bond funds and money market funds.
- The Sub-Fund will invest mainly in units of other UCITS and/or other UCIs selected and actively managed in accordance with the following limits:(Equity funds: Maximum 45%, Alternative investment funds: Maximum 45%, Mixed funds: Maximum 80%, Bond funds: Maximum 65%,Money market funds: Maximum 100%).
- The target profile of the portfolio (indicative only) will be a composite of 55% Bloomberg/EFFAS Bond Indices Euro Govt All > 1 year TR and 45% MSCI World AC TR (in EUR).
- Shareholders may redeem shares on demand, on a daily basis.
- The Sub-Fund may use financial derivative instruments for hedging purposes (including foreign exchange transactions) and to a limited extent for investment purposes.
- Notwithstanding the above provisions and if justified by exceptional market conditions, the Sub-Fund may invest up to 100% of its net assets in cash and cash equivalents, term deposits, debt securities and money market instruments.
- Non-distribution shares: any income generated by the sub-fund is reinvested.
- Please note that transaction costs may have material impact on performance.
- *Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within 5 years.*

#### Risk and Reward Profile

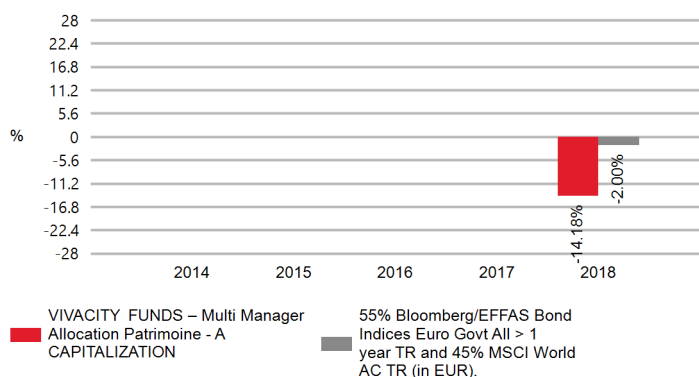
## Charges
