What is this product?

Type

- This product is a class of shares of the Sub-Fund and denominated in EUR. The Fund is an open-ended investment company with variable capital ("SICAV") and qualifies as an Undertaking for Collective Investments in Transferable Securities ("UCITS"), subject to Part I of the Luxembourg law of 17 December 2010 related to undertakings for collective investments ("Investment Fund Law"), transposing Directive 2009/65/EC related to UCITS.
- As an investment fund, the return of the Sub-Fund depends on the performance of its underlying assets.

Investment objective:

The Sub-Fund seeks to achieve medium to long-term capital appreciation, with added emphasis on the protection of capital during unfavorable market conditions.

Investment policy:

- The risk exposure to the market fluctuations is medium.
- No more than 60% will be invested in equities and equity-related securities. The remainder may be invested in debt securities and/or in money market instruments. No more than 10% of its net assets will be invested in units of other UCITS and/or UCIs.
- The Sub-Fund may invest up to 20% of its net assets in investment grade structured securities such as ABS, MBS or collateralized obligations with a pay-off linked to the relevant markets rather than actually investing in the markets.
- The Sub-Fund may use financial derivative instruments such as warrants, futures, options, swaps and forwards on currencies, interest rates and transferable securities (maximum exposure: 100%).
- The Sub-Fund may hold up to 20% of its net assets, in ancillary liquid assets which consist of bank deposits at sight in accordance with the provisions of Article 41(2) of the Law of 17 December 2010. Notwithstanding the above provisions; the above mentioned 20% limit shall only be temporarily breached for a period of time strictly necessary when, because of exceptionally unfavorable market conditions, circumstances such as the September 11 attacks or the bankruptcy of Lehman Brothers in 2008
- The Sub-Fund is actively managed without reference to a benchmark.
- This financial product does not promote environmental or social characteristics and does not have as its objective a sustainable objective.
- The investments underlying this financial product do not take into account the EU criteria for environmentally sustainable economic activities.

Given the above investment objective and policy and the risk and reward profile of the product, the recommended holding period is 5 years.

Redemption and dealing: Shareholders may redeem shares on demand, on a daily basis, which is a bank business day in Luxembourg. Distribution policy: Non-distributing shares: any income generated by the Sub-Fund is reinvested.

Intended Investor

The Sub-Fund targets informed investors who are advised to invest only part of their assets therein.

This share class is intended for:

- Financial intermediaries or distribution agents which, according to regulatory requirements are not allowed to accept and keep trail commissions (in the European Union, this will include financial intermediaries providing discretionary portfolio management or investment advice on an independent basis);
- Financial intermediaries or distribution agents rendering nonindependent investment advice and which according to individual fee arrangements with their clients are not allowed to accept and keep trail commissions.

There is no minimum investment.

Term

This product was incorporated for an undefined period. The manufacturer may not terminate it unilaterally. The board of directors may terminate this product under the conditions set forth in the prospectus.

What are the risks and what could I get in return?

Risks



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class.

This rates the potential losses from future performance at a medium level, and poor market conditions could impact our capacity to pay you. Not all risks affecting the Sub-Fund are adequately captured by the summary risk indicator.

This rating does not take into account other risk factors which should be considered before investing, these includes: credit risk, liquidity risk, counterparty risk, operational risk, use of derivatives, currency risk, duplication of certain fees and expenses, market risk and sustainability risk

Performance scenarios

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

The unfavourable, moderate and favourable scenarios shown are illustrations using the worst, average and best performances of the product over the last 10 years, by identifying, depending on the performance scenarios and as defined in the Key Information Document's EU regulation, all overlapping sub-intervals individually (i) equal in length to the recommended holding period which start or end in each month which are contained within that period of 10 years or (ii) equal or shorter in length to the recommended holding period, but equal to or longer than one year, which end at the end of that period of 10 years. Markets could develop very differently in the future.

The stress scenario shows what you might get back in extreme market circumstances.

Unfavourable: this type of scenario occurred for an investment between 31 March 2015 and 31 March 2020.

Moderate: this type of scenario occurred for an investment between 30 September 2017 and 30 September 2022.

Favourable: this type of scenario occurred for an investment between 27 December 2018 and 27 December 2023.

How long should I hold it and can I take money out early?

Recommended Holding Period ("RHP"): 5 years

The RHP has been defined by taking into account the above investment policy and risk and reward profile. You should be prepared to stay invested for at least 5 years. However, you can redeem your investment without penalty prior to the end of the RHP, or hold the investment longer. Investors may request redemption of shares no later than 3.00 p.m., Luxembourg time, on the business day preceding the next following valuation day. Redemption requests received after this time and date will take effect on the next following valuation day. The redemption price shall be paid no later than 2 business days following the applicable valuation day. Any cashing-in before the end of the RHP may have a negative consequence on your investment.
