What is this product?

Type

- This product is a class of units of the Sub-Fund and denominated in EUR. The Fund is an open-ended common fund with variable capital (*Fonds Commun de Placement* or "FCP") and qualifies as an Undertaking for Collective Investments in Transferable Securities ("UCITS"), subject to Part I of the Luxembourg law of 17 December 2010 related to undertakings for collective investments ("Investment Fund Law"), transposing Directive 2009/65/EC related to UCITS.
- As an investment fund, the return of the Sub-Fund depends on the performance of its underlying assets.

Investment objective:

- The objective of the Sub-Fund is to seek medium-term capital appreciation in EUR actively investing in an unconstrained and dynamic portfolio to seek opportunity in the global changes of interest rates and credit spreads.

Investment policy:

- The investment strategy of the Sub-Fund is to invest in government debt securities, money markets, cash and cash equivalents.
- The Sub-Fund will invest mainly in securities rated as investment grade. The exposure to non-investment grade securities will not represent more than 20% of the assets of the Sub-Fund.
- The Sub-Fund will not invest in bonds which are rated below speculative grade (CCC) by one or more of the main rating agencies (Moody's, Standard & Poors & Fitch), or in its absence, by a professional recognized rating agency registered and/or regulated by the European Securities and Markets Authority (ESMA).
- The Sub-Fund may take exposure to the emerging markets funds for up to 40% of its assets.
- The Sub-Fund shall not invest more than 10% of its assets in units of UCITS or other UCIs.
- The investment can be done directly or indirectly, through financial derivative instruments or other UCITS/UCIs.
- Within the limit of 500% of the Sub-Fund's net assets, derivatives will primarily be used to obtain investment exposure as a substitute for direct investment in securities, to hedge risks including interest rate curve risk, to implement relative value strategies, and to manage currency risk for both investment and hedging purposes. The range of instruments that may be used includes exchange-traded index futures and options, currency futures, interest rate derivatives, forward foreign exchange contracts, OTC derivatives entered under ISDA agreements, and government credit default swaps ("CDS"), which may represent up to 40% of the Sub-Fund's net assets.
- CDS may be used for risk management purposes (for example, to mitigate the impact of a widening in country spreads) or on a relative value basis to express views on the credit differential between sovereign issuers.

- The base currency of the Sub-Fund is the Euro but assets may be denominated in other currencies and currency exposure may be hedged.
- The Sub-Fund may hold, up to 20% of its net assets, in ancillary liquid assets which consist of bank deposits at sight in accordance with the provisions of article 41(2) of the Investment Fund Law. Notwithstanding the above provision, the above mentioned 20% limit shall only be temporarily breached for a period of time strictly necessary when, because of exceptionally unfavourable market conditions, circumstances so require and where such breach is justified having regard to the interests of the investors.
- This financial product does not promote environmental or social characteristics and does not have as its objective a sustainable objective.
- The investments underlying this financial product do not take into account the EU criteria for environmentally sustainable economic activities.
- The Sub-Fund is actively managed without reference to a benchmark.
- Given the above investment objective and policy and the risk and reward profile of the product, the recommended holding period is 5 years.

Redemption and dealing: This product is valued on each day which is a business day in Luxembourg (each a "Valuation Day").

Applications for conversion or redemption must be received by the UCI administrator no later than 12:00 p.m. CET on the the relevant Valuation Day. Redemption and conversion applications received after such time will be dealt with on the following Valuation Day.

Distribution policy: Non-distributing units: any income generated by the Sub-Fund is reinvested.

Intended Retail/Institutional Investor

This unit class is available for retail and institutional investors.

The minimum investment is EUR 100,000.

Term

The Sub-Fund and class of units were incorporated for an undefined period. The manufacturer and the depositary may terminate this product unilaterally under specific circumstances as describe in the prospectus. Unitholders may not request dissolution or liquidation of the Fund.

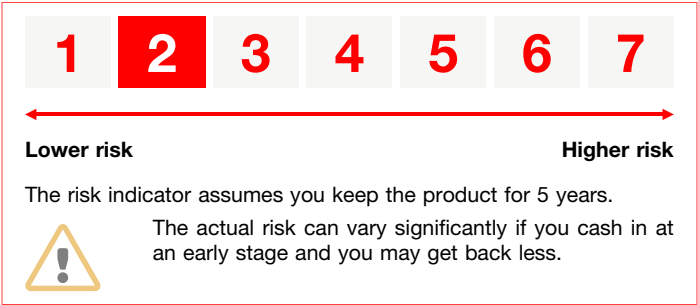

What are the risks and what could I get in return?

Risks



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 2 out of 7, which is a low risk class.

Performance scenarios

The figures shown include all the costs of the product itself, but may not include all the costs that you pay to your advisor or distributor. The figures do not take into account your personal tax situation, which may also affect how much you get back.

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

The unfavourable, moderate and favourable scenarios shown are illustrations using the worst, average and best performances of the product over the last 10 years, by identifying, depending on the performance scenarios and as defined in the Key Information Document's EU regulation, all overlapping sub-intervals individually (i) equal in length to the recommended holding period which start or end in each month which are contained within that period of 10 years or (ii) equal or shorter in length to the recommended holding period, but equal to or longer than one year, which end at the end of that period of 10 years. Markets could develop very differently in the future.

The stress scenario shows what you might get back in extreme market circumstances.

Unfavourable: this type of scenario occurred for an investment between 28 February 2018 and 28 February 2023.

Moderate: this type of scenario occurred for an investment between 28 February 2017 and 28 February 2022.

Favourable: this type of scenario occurred for an investment between 30 May 2020 and 30 May 2025.

What happens if Andbank Asset Management Luxembourg is unable to pay out?

What are the costs?

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed (i) in the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario and (ii) € 10,000 is invested.

How long should I hold it and can I take money out early?

Recommended Holding Period ("RHP"): 5 years

The RHP has been defined by taking into account the above investment policy and risk and reward profile. You should be prepared to stay invested for at least 5 years. However, you can redeem your investment without penalty prior to the end of the RHP, or hold the investment longer. Investors may request redemption of units no later than 12.00 p.m., Luxembourg time, on the applicable Valuation Day. Redemption requests received after this time and date shall be deemed to have been received in respect of the next following Valuation Day. Any cashing-in before the end of the RHP may have a negative consequence on your investment.

In order to prevent dilution effect, the Management Company has the power to charge a "dilution levy" on the subscription, redemption and/or conversion of units. If charged, the dilution levy will be paid into the Sub-Fund and will not exceed 2% of the relevant net asset value per unit.
